ENTRY GUIDELINES

START AN ENTRY NOW! FINISH UPLOADS BY SEPT. 26, 2018

The editors of NATURE'S BEST PHOTOGRAPHY invite all photographers to celebrate nature close to home in the 2018 BEST BACKYARDS PHOTO CONTEST. Submit images made in your own backyard, a public or private garden, or nearby park. Winning images will be featured in the next Spring/Summer edition of NATURE'S BEST PHOTOGRAPHY, in online galleries, and shared on social media. Entries are judged on technical quality, composition, originality, and artistic merit. Open to Professionals, Amateurs, and Youth.

ENTRY FEE: \$30 US for Adults / Free Entry for Youth (age 18 and under as of Sept. 26, 2018)

IMAGES PER ENTRY: For each paid contest entry, you may submit up to 25 images.

You may start as many paid entries as you like. If one or more of your images is selected as a finalist, we will require high resolution files for the final round of judging and reproduction in the magazine. **You have until 11:59 pm Eastern Standard Time, Sept. 26, 2018, but don't wait until the last minute to start your submission, as entries are judged in the order they are received.**

THIS CONTEST IS NOT JUDGED IN CATEGORIES. SUGGESTED BACKYARD TOPICS:

WILDLIFE: Wild animals from your backyard habitat (no captive animals are accepted)—birds, mammals, etc.

WATER LIFE: Ponds, streams, and wetlands in a backyard environment; also frogs, fish, and aquatic plant life.

PLANT LIFE: Flowers, trees, and other flora in their natural habitat (identify exotic or hybrid species) around your home.

PRIVATE BACKYARD GARDENS: Beautiful backyard (or frontyard) habitats that have been created to invite wildlife.

PUBLIC PARKS and GARDENS: Community parks and gardens close to home (please identify location).

SMALL WORLD: Close-up or macro shots of flowers or butterflies, caterpillars, insects, etc., in a backyard setting.

HOW TO SUBMIT YOUR PHOTOS ONLINE

- 1. PREPARE YOUR PHOTOS:** Save **COPIES** of your original images as low-resolution JPEGs (72 ppi) no smaller than 500k and no larger than 5mb. Save and label each image file in this way: your firstname_last name_species (keep short and separated by underscores). **Example: JohnDoe_fox.jpg**
- 2. LOG-IN OR CREATE A USER ACCOUNT** on the NBP website to enter your photos and manage your entries, check or replace images, edit/update captions before the final deadline:

- 3. USE THE "MANAGE MY ENTRY" BUTTON** at the bottom right of your account home page to get to the entry form for the current contest.

4. **UPLOAD PHOTOS** on the Online Entry Form. You will get a confirmation receipt by email with payment status and with a link to return to your entry.

After you start an account, you will see the “My Account Dashboard” account management tool found at the top right of the NBP website homepage. There you will be able to log in or out, update your contest account information, and go to lists of the contest entries associated with your account.

Photographers who have images that pass into the semifinal round of judging will be required to supply high-resolution files, RAW files if available, a complete caption, and your camera specifications before the final judging. Information on how to send high-resolution files will be provided.

HOW TO SUBMIT YOUR PHOTOS BY MAIL OR COURIER

Include BOTH low and high resolution files or your slides or transparencies along with the \$30 entry fee for adults and the completed Mail-in Entry Form (on the next page) with ALL the required information clearly filled out. PREPARING DIGITAL FILES TO MAIL

Digital images should be taken with the camera set for the highest possible resolution. Save copies of your images and label with your first and last name, underscore, brief image subject, and .jpg. (Example: **JohnDoe_fox.jpg**). Each flash drive, CD, or DVD must be labeled with your full name and phone number. PLEASE RETAIN A COPY of your submission, as the flash drives, CDs, or DVDs will not be returned after the contest. Prepare BOTH low and high resolution images using the following specifications:

- Low Resolution (72 ppi) JPEG COPIES of your images, about 1000 - 2000 pixels on the longest side, must be copied onto a flash drive or burned onto a single CD or DVD and labeled ‘LOW RES’ and your name for preliminary judging.
- High Resolution (300 ppi) unsharpened Tiff files, measuring 4800 pixels on the longest side, or largest file available, may be copied onto a flash drive or burned to as many CDs or DVDs as necessary for the final rounds of judging, each labeled ‘HIGH RES’ with your name on the discs. Tiff files, or the original RAW files, will be used for publication if selected as a winner. Please include copies of your original RAW files, if available. Note: we do not publish the RAW image.

IMPORTANT RULES

** Images should be of non-captive species in natural situations. If lured or baited, please explain. **

ALL PHOTOS MUST accurately reflect the subject matter as it appeared in the field. Nothing should be added to an image, and aside from dust spots, nothing should be taken away. Normal processing of RAW image files and minor adjustments to color and contrast are acceptable, as is cropping. HDR and focus stacking are permitted as long as all manipulation is disclosed. No watermarks or text on photos.

ENTRANTS MUST NOT infringe on the rights of any other photographer or person, Federal regulations, or private land permissions, and MUST NOT ENTER images of captive wildlife or that involve the willful harassment of wildlife or damage to the environment by the photographer.

Note: Images that do not comply with contest rules will be eliminated.

ENTRY FEE AND ENTRY FORM:

The entrance fee for adults of \$30 US per entry of 25 images may be paid with Visa, MasterCard, or American Express charge card on your entry form, or phone in your information to 703-467-9783 on M-F from 10am-5pm EST. They may also be mailed with a check (US dollars only—*NO foreign checks or foreign money orders*) made out to: NATURE’S BEST PHOTOGRAPHY. Each submission must be accompanied by an Mail-in Entry Form with all information clearly filled out.

The NBB competition is open to ALL photographers except employees of NATURE'S BEST PHOTOGRAPHY magazine. Your entry to this contest constitutes your agreement to allow your photographs, your name, occupation, city and state of residence to be published as selected award winners in NATURE'S BEST PHOTOGRAPHY magazines, print and digital exhibitions, events, and other public venues, published on websites owned by or in alliance with NBB as award winners, and used for promotions of the NBB. **Entrants retain ownership and all other rights to future use of their photographs.** NATURE'S BEST PHOTOGRAPHY shall have the right to verify, in their sole judgment, winner eligibility.
